



**ARCADIA RESOURCES EXTENDS
DAILYMED AGREEMENT FOR THREE YEARS
WITH WELLPPOINT STATE SPONSORED BUSINESS**

INDIANAPOLIS, Ind., August 9, 2010 –Arcadia Resources, Inc. (NYSE Amex: KAD), a leading provider of innovative consumer health care services under the Arcadia HealthCareSM brand, today announced the execution of a new three-year agreement to offer the DailyMedTM pharmacy medication management program to high-risk Medicaid members in select states where WellPoint companies provide Medicaid managed care benefits.

DailyMed is currently offered or administered by WellPoint affiliated health plans in Virginia, California and South Carolina and will be launched in Kansas later this year. WellPoint's State Sponsored Business Division serves nearly 1.8 million members in 10 states who are enrolled in Medicaid, State Children's Health Insurance Programs, and other state sponsored health care programs. Financial terms of the agreement were not disclosed.

DailyMed Pharmacy (www.DailyMedRx.com) is Arcadia's proprietary medication adherence program that dispenses a monthly cycle of a patient's prescriptions, over-the-counter medications and vitamins, and organizes them into pre-sorted packets clearly marked with the date and time the medications should be taken. In the dispensing process, a DailyMed pharmacist reviews each patient's medication profile and utilizes state-of-the-art medication therapy management tools to improve the safety and efficacy of the medications being dispensed. A DailyMed pharmacist provides routine communication with the patient, the primary care physician, caregivers and payers to maximize the pharmaceutical care administered. The DailyMed program improves patient care and drug utilization while reducing drug and hospitalization costs for private and government payers.

"We first launched DailyMed with the mutual goal of helping our members better manage their healthcare", said Kevin Hayden, President of WellPoint State Sponsored Business. "Now one year later, we are extending our agreement with Arcadia as DailyMed has become an integral part of our programs, which are designed to identify members with specific medical conditions and ensure that they are taking the right medications at the right time all under the supervision of a licensed pharmacist who has access to and understands each member's individual prescription regime."
